Resolution & Order No. 2022-155

In the matter of a personal services contract between TracePoint, LLC., and Linn County.

Tracepoint is currently providing Linn County with a trial license of Carbon Black, an EDR (Endpoint Detection and Remediation) product which detects malicious software, such as ransomware, and immediately locks a computer or server. This software alerts a central station of the malicious code when attempted to be executed. When malicious code is detected the computer/server remains locked and is returned to the previous state or repaired. Once corrected, the computer/server is able to return to normal duties. The central station is currently watching over every computer and server within our organization.

Financial Impact:

\$91,700 for 14-months with an ending date of June 30, 2023.

Staff Recommendation:

The recommendation from Steve Braaten is to proceed with the purchase of this software for a 1-year term and then evaluate renewal options.
