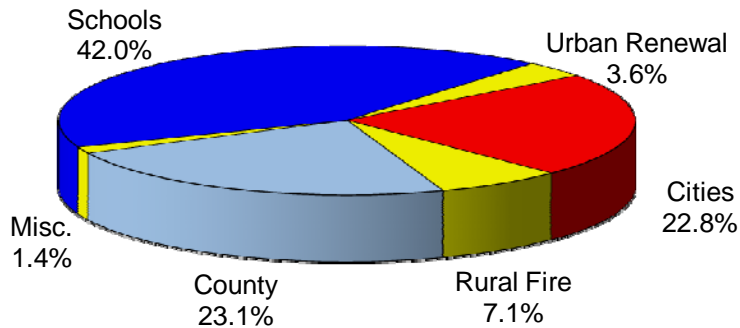

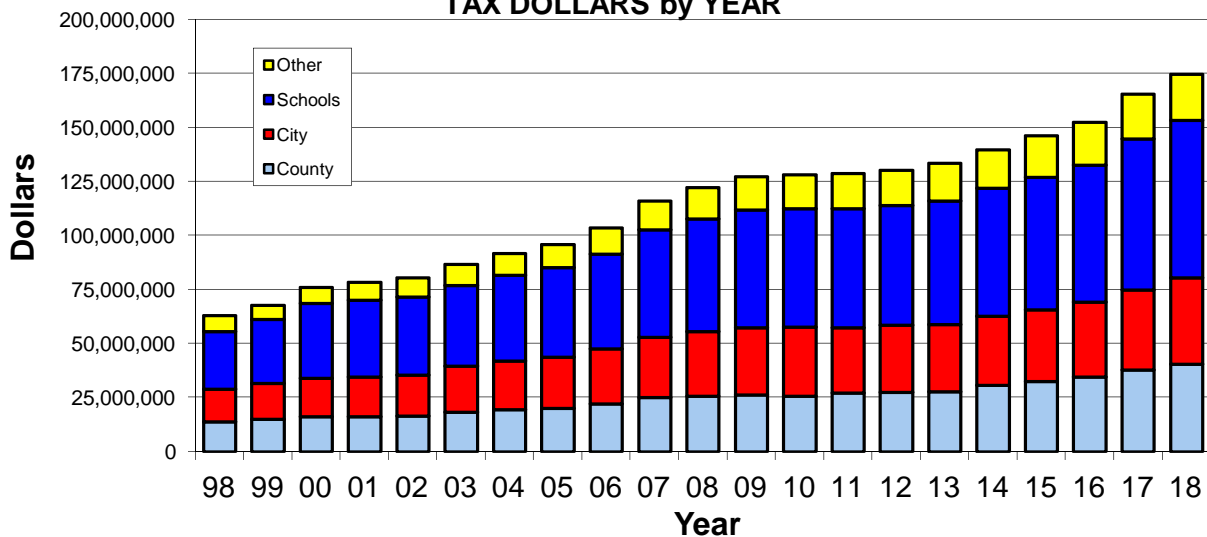

This summary is designed to provide information about the current Assessment and Tax Roll. More detailed or specific information is available from our office, located in room 214 of the County Courthouse at 300 4th Ave SW in Albany.

If you have questions concerning property you own or more general questions about the property tax system, you are welcome to discuss your situation with a member of our staff. If you are eligible for a program to help reduce your property taxes, we will gladly help in any way we can.

Ad valorem taxes are based on the assessed value of your property as of January 1st. Those taxes provide funds for the operation of schools, cities, fire districts, and other miscellaneous taxing districts.

The Assessor does not tax, but values your property through methods prescribed by state law and regulation. The Assessor does not determine the amount of money your taxing district receives. To control spending, you should take an active interest in local budget meetings and elections. You are, in effect, purchasing services with your tax dollars.

Taxes are due and payable in three installments. The first third is due on November 15th, the second third on February 15th, and the final third on May 15th. A three percent discount will be allowed on taxes paid in full on or before November 15th. A two percent discount will be allowed if two-thirds of the total taxes are paid on or before November 15th. No discount will be allowed on taxes paid after November 15th. Interest at a rate of 1-1/3% per month or fraction of a month will be charged on any payment made after the installment due date.

By law this office must credit your property tax payments to the earliest year for which taxes are due on your property. In order to receive a discount on your current year's bill, all prior year's taxes, penalties and interest must first be fully paid.
