### CHAPTER 420

#### PLANNING COMMISSION CODE

#### 420.200 Members

(A) The Commission shall consist of nine (9) members, all of whom shall be residents of Linn County and at least five (5) of whom shall reside outside cities.

(B) Members shall be appointed by the Board, for terms of four years, or until their respective successors are appointed and qualified, except that the initial membership shall consist of the following persons who are hereby the Commission:

#### 420.300 Election of officers; adoption of rules

At the initial or first meeting after the annual appointment of members, the Commission shall organize by the election of a chairman and secretary, and shall initially adopt rules for the transaction of the business of the Commission.

#### 420.005 Title

This Chapter, LCC 420.005 to 420.500, shall be known and cited as the “Linn County Planning Commission Code” or simply as the “Planning Commission Code.”

#### 420.010 Definitions

As used in this Chapter:

“**Commission**” means the Linn County Planning Commission.”

#### 420.400 Powers and authority

The Commission shall exercise the powers conferred it by ORS 215.010 to 215.190, and the Linn County Code as enacted by the Board , and amendments thereof.

#### 420.100 Planning Commission established

There is hereby established the Linn County Planning Commission, which shall act pursuant to the authority granted by ORS 215.010 to 215.190, and the Linn County Code made pursuant thereto.

**420.500 Duty to adopt County zoning legislation**

Pursuant to the exercise of the powers referred to in LCC 340.400, the Commission shall promptly either adopt a comprehensive land use plan and recommend a zoning ordinance, or shall recommend an interim zoning ordinance to be effective for not more than three years.
