I. Introductory Provisions

4.010 Caption

(A) BEFORE THE BOARD OF COUNTY COMMISSIONERS FOR LINN COUNTY, OREGON

(B) IN THE MATTER OF DESIGNATING SMOKING AND NO SMOKING AREAS WITHIN LINN COUNTY BUILDINGS

[Adopted 91-489 eff 8/15/91]

4.050 Authority

(A) The Board of County Commissioners for Linn County, having the authority granted by ORS Chapter 203 and LCC 2.10.100 to regulate the use of County buildings, and being advised of the provisions of ORS 433.835 through 433.875 and Division 15 of Chapter 333, Oregon Administrative Rules, relating to the Oregon Indoor Clean Air Act, by Order 89-206, designated no smoking areas in the Linn County Courthouse, Armory, Courthouse Annex and Hurd Building;

(B) Now, having considered the recommendations made by an employee committee, “The 1991 Smoking Committee” [adopts this special order].

II. Specific Provisions

4.100 Designated no-smoking areas

(A) [The Board ORDERS] that the Linn County Courthouse, Courthouse Annex, and Hurd Building be affirmed and continued as set forth below:

(1) All of the Linn County Courthouse is designated a “No Smoking” area, except, the employee lounge in the basement level, depicted as Room 13 on Exhibit 1 hereto, is designated a “Smoking Allowed” area, and

(2) All of the Courthouse annex is designated a “No Smoking” area, and

(3) All of the building formerly known as the Hurd Building, located on the northeast corner of the block bounded by 3rd, 4th, Broadalbin and Ferry Streets, Albany, is designated as a “No Smoking” area.

(B) [The Board] furthered ORDERED that:

(1) All of the Old Armory building is designated a “No Smoking” area.

(2) The Road Department Administration Building is designated a “No Smoking” area, except smoking will be permitted in the room off the main accounting area that has an outside vent.

(3) The Road Department Shop Building in Albany is designated a “No Smoking” area, except smoking will be permitted in the fabrication room.

(4) The Road Department Sign Shop and Bridge Building is designated a “No Smoking” area, except smoking will be permitted in the Sign Shop and in the Bridge Room.

(5) The Road Department Service Station area is designated as a “No Smoking” area.

(6) All of the Dog Control complex is designated a “No Smoking” area, except smoking will be permitted in the euthanasia room and the covered area between the office and the kennels.

(7) All of the General Services building, 330 SW Third Street, Albany, is designated a “No Smoking” area.

4.200 Repealer clause
