RENEWAL OF FIVE-YEAR LOCAL OPTION LEVY FOR K-12 EDUCATION

**Question** 20 words which plainly phrases the chief purpose of the measure.

Shall district renew levy of \$1.50 per \$1,000 of assessed value for five years beginning in 2017-2018 for K-12 education? This measure renews current local option taxes.

**Summary** 175 words which concisely and impartially summarizes the measure and its major effect.

This measure would continue the local option levy originally approved by voters in 2006 and renewed in 2010. The current levy expires June 30, 2017. If renewed, the current levy rate would not increase.

The Corvallis School District will use the revenue from this measure to fund teachers at all schools to sustain class sizes; instructional coaches to improve teaching and learning; music, physical education and art instruction for elementary students; vocational and technical education opportunities; counseling for students; and support for high school athletics and activities.

The proposed levy will raise approximately \$4.3 million in 2017-2018, \$4.4 million in 2018-2019, \$4.5 million in 2019-2020, \$4.6 million in 2020-2021, and \$4.7 million in 2021-2022 for a total of \$22.5 million. This amount would support the equivalent of about 50 full-time teaching positions annually.
