**Summary** 175 words which concisely and impartially summarizes the measure and its major effect

Approval of this measure would prohibit the establishment of the operation of retail marijuana producers, retail marijuana processors, retail marijuana wholesalers, and marijuana retailers in areas of Linn County that are outside of incorporated cities.

Oregon law provides that a county governing body may adopt an ordinance that prohibits the establishment of retail marijuana producers, retail marijuana processors, retail marijuana wholesalers, and marijuana retailers in unincorporated areas of the county, but must submit the measure of the ordinance to the electors of the county for approval at the next statewide general election. The Linn County Board of Commissioners adopted Ordinance 2015-379 prohibiting the establishment of retail marijuana producers, retail marijuana processors, retail marijuana wholesalers, and marijuana retailers in the unincorporated areas of Linn County for referral to the electors of Linn County.

Approval of this measure would not prohibit the personal use of recreational marijuana nor the use or growing of medical marijuana under the Oregon Medical Marijuana Program in areas of Linn County that are outside of incorporated cities.
