Should the City continue the Police Operating Levy beginning in fiscal year 2022 to maintain current services another five years?

This measure renews current local option taxes.

**Summary** 175 words which concisely and impartially summarizes the measure and its major effect.

Renewing this five-year local option levy would extend the City of Sweet Home Police Services Operating Levy through June 2026.

A "YES" VOTE RETAINS SWEET HOME'S POLICE SERVICES OPERATING LEVY.

The levy would begin July 1, 2021 with all revenues received used to provide continued funding for the City's Police Department. This five year levy would produce at its current rate of \$7.85 per \$1,000 of assessed value an estimated total of \$16,017,681.40 from the following estimated annual authorizations to levy: \$3,045,917.39 in 2021; \$3,099,402.06 in 2022; \$3,151,456.12 in 2023; \$3,203,843.96 in 2024; and \$3,517,061.86 in 2025.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of estimate and may reflect the impact of early payment discounts, compression and the collection rate.


