



## DETENTION VISITING RULES

Below are the visiting rules pertinent to the Linn-Benton Juvenile Detention Center.

Due to the limited space and intake activity, crisis or youth behavior, all visits are subject to delay, abbreviation or cancellation. Failure to follow the rules outlined or directions of the detention staff will result in visitation being automatically discontinued until review by the Detention Manager or designee.

### VISITING HOURS

*Effective February 2017*

Visitation Schedule:

**Monday & Wednesday evenings**

7:00pm—9:00pm

**Saturday & Sunday:**

12:30pm-2:30pm and 7:00pm -9:00pm

Parents and guardians may have a visit within the first 24 hours of a juvenile arriving at detention. You will need to call and schedule the visit ahead of time.

Each juvenile is permitted **(1) one (15) fifteen minute** visit with no more than **3** people per visit. Requests for additional visits maybe granted upon approval of the Detention Manger or designee.

**Visits will be by appointment only.** Please call during regular business hours to schedule an appointment. The allotted fifteen minutes may be subject to change based on the number of visits scheduled.

- Parents or legal guardians will be allowed one visit during the first 24 hours.
- There will be absolutely no visitors under 18 years of age.
- The entire Oak Creek Facility including the parking lots is smoke free. There are no designated smoking areas. All smoking is prohibited.
- No contraband e.g., knives, guns, purses, keys, lighters, cigarettes, chew, gum, candy, letters, cell phones, etc.; will be allowed in the visitation room.
- All visitors will be required to go through a metal detector prior to entering the visiting area. There will be no lockers available, so any valuable items should be secured in a vehicle.
- Visitors must show valid I.D. before visitation will be allowed.
- Food and drinks are not allowed.
- Any individual found loitering outside the Linn-Benton Detention Facility will be directed to leave the grounds.
- Any violation of these rules will result in visiting privileges being terminated.
