Defendant is placed on Bench Probation for a period of 24 month(s) and shall be subject to the following conditions of Probation:

- Stipulate that the following is/are a nuisance and shall be destroyed: Items in SMS Case #
- It is hereby further ordered and adjudged that the clerk apply payment upon this money award as provided by law and apply any bail or security on deposit herein toward this money award and, to the extent permitted by law, disburse them first to compensatory fines, then to restitution, Crime Victim Assessment, fines, assessments, fees and then to other costs adjudged herein.
- Appear in Court at the Marion County Court Annex located at 4000 Aumsville Highway, Salem, Oregon, on 1/5/2019 at 10:00 am, to show proof of completion.
- Participate in a substance abuse evaluation. Enter and successfully complete any course of treatment, including after and follow-up care determined to be necessary and as designated by the Evaluator or the Probation Officer. MW Services.
- Do not have contact with anyone who use or possess controlled substances illegally, or from going to places where such substances are kept or sold.
- Do not use or possess alcohol, intoxicants, inhalants or controlled substances.
- Do not enter into bars, taverns or liquor stores.
- Do not participate in the Oregon Medical Marijuana Program.
- Obey all municipal, county, state and federal laws.
- Enter into and successfully complete a parenting class.
- Do not have contact with the victim without waiver, compliance with treatment and Court or Probation Officer permission. and Per DHS.

This is a stipulated sentence.

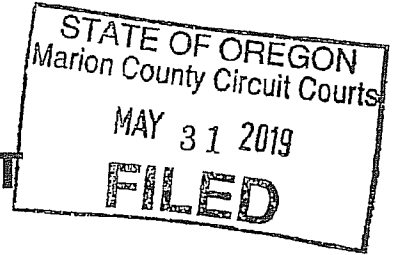

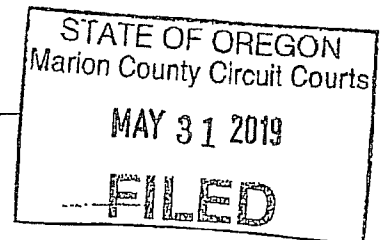
